Jaipur, April 5 (IANS) Prime Minister Narendra Modi on Friday launched a scathing attack on the opposition, saying the Congress never permitted soldiers to get even with the enemy.

Addressing a mammoth rally in Rajasthan's Churu in support of paralympic Devendra Jhajahria, PM Modi said that things have changed now things have changed now as "the enemy knows that this is New India, which enters into enemy territories to give a befitting reply to them (Yeh Naya Bharat hai jo ghar mein ghus ke marta hai)."

"As long as the Congress people remained in power, they kept the hands of our soldiers

RBI's decision on 3rd-party UPI apps to democratise wallet market: Experts

New Delhi, April 5 (IANS) Industry experts on Friday welcomed the move by the Reserve Bank of India (RBI) to permit the use of third-party UPI apps for making digital payments from prepaid payment instruments (PPI) wallets.

PPIs can come in the form of payment wallets, smart cards, magnetic chips, vouchers and mobile wallets, etc.

At the moment, UPI payments from PPI can only be through the web or mobile app provided by the PPI issuer.

Shivaji Thapliyal, Head of Research and Lead Analyst, Yes Securities, said that at the moment, the wallet market had been thrown wide open due to the RBI's diktat on Paytm Payments Bank.

The new guideline, in

a sense, serves to make PPI wallets somewhat inter-operable democratises the wallet market to that extent," said Thapliyal. In FY23, Paytm Wallet

had a gross merchandise value (GMV) of \$19.1 billion, with Mobikwik being a distant second with \$1.01 billion GMV. "It would be interesting

to see what scenarios could emerge if third party UPI apps, which would include Paytm, would be able to access other PPI wallets," Thapliyal noted. With the RBI's move,

the PPI wallet holders will not have to be completely dependent on the issuer of the PPI wallet. It would, thus, enhance

customer convenience and boost adoption of digital payments for small value transactions.

Furthermore, the RBI's decision to keep the repo rate unchanged at 6.5 per cent aligns with expecta-tions, said Shishir Baijal, Chairman and Managing Director, Knight Frank In-

"It provides added sup-port to consumers, ensur-ing economic growth re-mains robust. Further-more, the RBI Governor's optimism is bolstered by the resilience in domestic macro fundamentals," he

Sanjay Agarwal, Founder, MD and CEO, AU Small Finance Bank, said the RBI's maintenance of status quo on the repo rate and the policy stance marked by 'withdrawal of accommodation' is a "prudent decision amid increasing geopolitical un-certainties and any adverse climate impact".

Arun Gawli to get premature release from life term

Nagpur (Maharashtra), April 5 (IANS) In a signifi-cant development, the dreaded ex-mafia dondreaded ex-matia don-turned-politician Arun Gu-lab Gawli is set to be freed prematurely from the life term he is undergoing in Nagpur Central Jail, as per a Bombay High Court or-der, here on Friday.

A division bench comprising Justice Vinay Joshi and Justice Vrushali Joshi has allowed a criminal rehas allowed a criminal re-petition filed by Arun Gawli challenging the rejection of his previous plea claim-ing premature release giv-en a government notifica-tion of January 10, 2006. "Gawli's application was rejected on grounds that the state government

that the state government had come up with a fresh notification on December 1, 2015, by which a convict under the MCOCA Act

was held entitled to the benefit of the policy decision," his lawyer Mir Nag-man Ali told IANS shortly afterwards.

The state had registered Gawli's petition on the ground that the 2015 notification specifically excludes the convict under MCOCA from the benefits of the policy. It contended that even the 2006 notification makes it clear that convicts under laws like the NDPS, TADA, MPDA, etc., are not entitled to the 2006 policy benefits, explained Adv. Ali.

After hearing both sides, the court directed the state to decide on Gawli's release within four weeks from Friday, paving the way for his premature release from the jail where he has spent 16 years, added Adv. Ali.

ED cracks down on Pune ponzi kingpin, seizes Rs 24.41 cr in bank accounts

New Delhi, April 5 (IANS) The Enforcement Directorate has issued a provisional attachment order' attaching movable assets worth Rs 24.41 crore of various individuals, entities and firms which are used by Vinod Khute, owner of the Punebased VIPS Group of Companies and Global Affiliate Business Company, in an alleged money laundering case, an official

said on Friday.

According to ED, the attached assets, under the provisions of the Prevention of Money Laundering Act (PMLA) of 2022, are in the form of balance in 58 bank accounts amounting to Rs 21.27 crore and

deposits of Rs 3.14 crore. The probe agency has

commenced an investiga-tion following an FIR lodged by the Bharti Vidyapeeth Police Station in Pune. The FIR, filed under various sections of the Indian Penal Code, 1860, implicates Vinod Tukaram Khute, Santosh Khute, Mangesh Khute, Kiran Pitamber Anarase, Ajinkya Badadhe, and unidentified others.

They are accused of deceiving individuals and conspiring to entice them into a Ponzi scheme and forex trading with promises of high returns. This resulted in the collection of over Rs 100 crore in the bank accounts of numerous fraudulent firms and entities.

"ED investigation revealed that Vinod Khute who is absconding and suspected to be presently residing in Dubai, is the mastermind of various illegal trade, crypto exchange, wallet services, and forex trading through Dubai-based firm M/s Kana Capital Limited," said ED in a statement issued on Friday.

Faizabad will celebrate the return of Lord Ram in 2024 polls

Faizabad (Uttar Pradesh), April 5 (IANS) It is the land of Lord Ram, celebrating the return of the deity after 500 years. Yet the Faizabad constituency, which ensconces Ayodhya city, has not been kind to women as the constituency has never elected a woman candidate since 1951.

The major political parties have not fielded any woman candidates and the ones who did contest

were independents.
Former UP chief minister Suchitra Kripalani did contest the Faizabad seat

in 1971 but lost.
"There is no specific reason why women have

not won from here. Major political parties did not field women candidates and this could be a reason," says Rakesh Tiwari, a local journalist. This year's election is rather special for Faizabad, now renamed as Ayodhya district. The year marks the opening of the grand Ram temple and also the massive infrastructural development of the holy city.

"The BJP has completely transformed Ayone and a source of the holy city."

Lallu Singh is being challenged by Samajwadi

BJP aims to repeat win in K'taka's Dakshina Kannada LS seat

Bengaluru, April 5 (IANS) Dakshina Kannada Lok Sabha Seat in Karnataka is considered a bastion of the BJP as the party has remained unbeatable here since the 1991 Lok Sabha election.

The parliamentary seat in the state's coastal part has the most Hindu pilgrimage centres.

The BJP has denied a ticket to three-time parliamentarian and former state president of the party, Nalin Kumar Kateel. The ticket has been allotted to a loyal party worker, fresh face, and ex-serviceman, Captain Brijesh Chowta. The Congress party has fielded R. Padmaraj, an advocate from Mangaluru city. After retiring from the Army, Captain Chowta, who hails from the influential Bunt community, was associated with the Rashtriya Swayamsevak Sangh (RSS) and later worked for

the BJP party.
Congress' Padmaraj
hails from the Billava community, which is dominant in the region. The Congress party wanted to field Assembly Speaker U.T. Khader from the seat considering his popularity among all sections of society. However, with Speak-er Khader refusing the of-fer, the party had to field Padmaraj.

Sources in the Congress said that Padmaraj was preferred over other minority candidates considering the chances of winning. The Congress is also playing the caste card this time to achieve victory. Sources, however, said that there is no place for caste politics in the region, unlike other parts of Karnataka. The murder of Praveen Kumar Nettaru, a BJP youth leader, at the height of the hijab controversy on July 26, 2022, rattled the region and resulted in a series of communal clashes and murders.

A probe by the National Investigation Agency (NIA) revealed that members of the Popular Front of India (PFI) were involved, and Nettaru's mur-der was part of a larger conspiracy to strike terror among the members of a section of society.

The appointment of Nettaru's wife by the previous BJP government on a contractual basis and then her removal by the current Congress government made an impact in the re-

gion. After backlash, the Congress government was forced to reinstate her.

The Congress party held the previous Manga-luru or South Canara MP Seat from 1957 to 1989. Veteran Congress leader Janardhan Poojari secured the seat for the party in the 1977, 1980, 1984, and 1989 general elections.
